Subject: Competency level for the finalization of direct online purchase of Goods/ Stores & Services on Government e-Marketplace (GeM) - Adoption of Government e-Marketplace (GeM) by the State.

The State Government in Industries & Commerce Department Haryana vide G.O. No. G.O. No. 2/2/2016-4I BII (1) of even dated has inserted Rule-7.1 after Rule-7 in "Procedure & Rules for the Purchase of Stores (PFR Volume-II) (Appendix-14) applicable to Haryana (As on 01.10.2015) for the adoption of Government e-Marketplace (GeM) by the State.


