Whereas in pursuance of the judgement dated 11.7.97 of the Hon'ble Supreme Court in C.A.Nos. 422, 423, 424 of 1993, C.A.Nos. 448-49/93, 452-53 of 1993 and C.A.Nos. 44-46 of 1996, a tentative seniority list in respect of Class-I Officers of the Public Health Deptt. was drawn up in the light of the provisions of the Act No. 20 of 1995 which was circulated to all concerned vide order dated 10.10.97, issued under Endst.No. 2/40/97-PH(I), dated 13.10.97 through Engineer-in-Chief inviting objections if any.


