In view of the above, it is requested that immediate necessary action may be taken for preparation/submission of DNITs, as per competency and early finalization of tenders etc. for all such projects which have been submitted to NABARD for approval during the current financial year.

This may be given Top priority with an objective of ensuring that all procedural formalities are completed by the time the formal sanctions are received from NABARD.

In order to facilitate the implementing Departments for expeditious implementation it has been decided that Departments can initiate the process of grounding projects by obtaining administrative approval, forest clearance, land acquisition etc., and may call for tenders in anticipation of sanction of project by NABARD. The same was recorded in the minutes of the meeting headed by the Hon'ble Chief Minister on 04.07.2019 and communicated vide Finance Department U.O. of even number dated 22.07.2019.

3. This issue was also discussed in the meeting of High Powered Committee (HPC) held on 29.07.2019 headed by the Chief Secretary. Accordingly, it is again clarified that Departments can initiate the process of grounding projects by obtaining administrative approval, forest clearance, land acquisition etc., and may call for tenders in anticipation of sanction of project by NABARD.


