3.	Four members to be selected other than, Panches and Sarpanch may be from amongst all social sections of the village community who have demonstrated committed leadership and worked in the past for the overall development of the village and community. This may include youths in the villages, members of Self Help Group, retired teachers, ex-service men, Anganwari workers, ASHA, village Chokidar, Mahila Mandal Pardhan etc.	
4.	Junior Engineer from Development and Panchayats Department	Member
5.	Gram Sachiv (Secretary Gram Panchayat)	Convener
6.	Junior Engineer from Public Health Engineering Department	Technical Member

Operational guidelines for the implementation of Jal Jeevan Mission has been released by Hon'ble Prime Minister on 25.12.2019. Vide clause 5.4 of JJM guidelines, constitution of VWSC's have been elaborated, highlighting the woman participation in community managed drinking water supply systems. It has been

stressed that woman participation should be more than 50% in VWSC's, which is key to success towards ultimate goals of JJM.

Keeping in view the JJM guidelines it has been decided by the competent authority that the woman participation should be ensured above 50% in all the VWSC of the state. If VWSC's have already been constituted the same may be reconstituted by ensuring more than 50% woman participation. The reconstituted VWSC members and new resolution of the Gram Panchayat be uploaded on the departmental website by concerned district consultant WSSO.
