Subject:- To review performance of various departments under convergence with MGNREGS- FY(2020-21).

In continuation to this office memo No. 23286-300-PHE/Prog dated 25.02.2020, No. 32167-239-PHE/Prog. dated 20.03.2020 and No. 34528-34600-PHE/Prog. dated 23.04.2020.

Kindly refer to this office memo No. 119768-9782-PHE/Prog. dated 05.12.2019, No. 16079-93-PHE/Prog. dated 05.02.2020, on the subject noted above.

In this regard, it is intimated that a State level Convergence Meeting to review the performance of various departments under Convergence with MGNREGS was held on 18.05.2020 under the chairmanship of Hon'ble Chief Minister, Haryana, wherein it has again been emphasized that efforts be taken for maximizing works under MGNREGA as per government initiative to promote rural economy during the COVID-19 crisis by placing money at disposal of poor labourers in these difficult times, while completing the maintenance works.

I have been directed to request you to take up maximum works under MGNREGA. Only works that qualifies to be taken up under this programme be taken in hand, as clarified vide this office memo No. 86821-48 PHE/Plg. dated 29.05.2012 (copy available on Departmental website), which are also indicated below for reference:-

- (i) Cleaning of tanks (Storage and Clear Water Tanks).
- (ii) De-silting /cleaning of open channels.
- (iii) Dressing, jungle clearance and plantation at water works.
- (iv) Filter media washing (top layer) i.e. taking out, washing and replacing of top layer filter media.

- (v) Construction of soak pits.
- (vi) Construction of recharge pits to replenish ground water.

It is also pertinent here to mention that the works under the above said categories shall not be executed through contractors/ on quotations.

It is recommended that photographs be taken before the commencement of the work and after completion of work for having a authentic record in this regard to avoid any inter departmental disputes at any stage.

It is, therefore, again requested that estimates for the above works may be prepared immediately and send to CEO/Zila Parishad/ADC/DC (and same shall be got sanctioned from the District Administration by pursuing the matter.

It is further requested that the total works projected under MGNREGS may be taken up as per the circle target given below:-

The targets will be treated as KPI and will be reviewed online as well as during all meetings.

You are also requested to submit a list of works to be undertaken MNREGS along with estimated cost as cleared by CEO Zila Parishad. This list shall be submitted after achieving the target by 29th May, 2020 positively through E-mail @ eeplanning@phedharyana.gov.in.

The above instructions may be followed meticulously both in letter and spirit & also be brought into the notice of all the concerned officers/officials.
