Minutes of the VC held on 28.06.2022 at 3:00 PM under the Chairmanship of Chief Engineer (Monitoring) regarding - updation of data / entry of additional details of all existing contractual / outsourced employees including manpower engaged on job work on the webportal of Haryana Kaushal Rozgar Nigam Limited.

The officers present in the VC as per list enclosed.

Chief Engineer (Monitoring) welcomed all the participants and apprised the progress made so far regarding data updation of manpower / data sent to Nigam by the concerned DDOs through HKRNL portal. It was observed that there are 67 DDOs in the field offices who were supposed to update the data of manpower on HKRNL portal out of which 24 No. DDOs have not yet started the data updation on the portal at all and 33 No. DDOs have not sent the data of manpower to Nigam through portal. It was further observed that data of 11883 contractual employee have been mapped with PPP out of which data of only 4429 contractual employees (only 37.3% of the total) has been updated on the portal and data of only 1814 contractual employees (only 41% of the updated data) has been sent to Nigam.

Inspite of repeated instructions issued vide Head Office memo No.2898-2970 dated 12.01.2022, No.4607-4679 dated 19.01.2022, No.21719-791 dated 10.03.2022, No.33931-34003 dated 19.04.2022, No.41756-41828 dated 12.05.2022 and No.45437-509 dated 23.05.2022 No.47437-509 dated 27.05.2021, No.49006-49078 dated 01.06.2022, No.51383-51455 dated 10.06.2022, no satisfactory progress is there regarding updation of data of manpower / sending of data to Nigam.

DDO wise progress was discussed in the VC as per the status as on 28.06.2022. The following directions were issued to the DDOs:-

- The data of manpower mapped with PPP through e-salary login IDs by DDOs 1. seems to be very huge in number i.e. 11883. The same needs to be reverified as per the provisions taken in the annual maintenance estimate.
- The necessary budget provision for the salary of the contractual manpower may 2. be made in the budget estimates / annual maintenance estimate for the corresponding year to ensure regular payment to HKRNL for further disbursement of salary to the contractual manpower by HKRNL. Further, it may be ensured by the concerned SEs / EEs that they port the data of existing contractual manpower in accordance with the provisions made in the technically sanctioned budget estimates / annual maintenance estimates for the corresponding year and no contractual manpower in excess to the approved provision by the competent authority be ported to HKRNL portal.
- The data of lab attendants deployed on contractual basis in Labs by PHED must 3. be also updated on the HKRNL portal / send to Nigam. In case designation of Lab Attendant is not available on the portal, the same must be created on the portal as per the provision.

4. After re-verification of data, the necessary updation of data of manpower and sending to the Nigam must be completed within two day i.e. upto 30.06.2022 and thereafter, all the DDOs shall furnish a certificate to the effect that all the data pertaining to their jurisdiction has been updated and sent to Nigam through HKRNL portal. The said certificate must be submitted by all DDOs on 01.07.2022.

5. The data of manpower must be simultaneously sent to Nigam once it is updated on the portal.

6. This is the last opportunity for entering the data / sending the data of contractual manpower on the portal and no further directions would be issued in this regard. In case any failure in updation of data / sending the data is observed w.e.f. 01.07.2022, then it would attract disciplinary action against the defaulting DDOs.
