**Subject: Close monitoring of Power and Water supply position/15.04.2024 to 30.06.2024.**

As you are aware the summer season has set in and the IMD has predicted higher than normal temperatures till the end of June 2024. The demand of water and power is expected to reach higher than ever before levels and thus it is necessary to close the monitor and address the same. The HPU's and PHE departments are directed to establish control room at Head office to respond to any criticality in the water and power supply. The control room shall operate round the clock from 15<sup>th</sup> April 2024 to 30<sup>th</sup> June 2024. As the power supply position also affects the water supply it is necessary to work in close coordination so that these essential services are adequately and satisfactorily provided to all in the State.

The following Monitoring & Coordination Committee (MCC) is hereby formed:-

1. Director Operations, HVPN
2. Director Operations, UHBVN
3. Director Operations, DHBVN
4. Director Technical-II, HPGCL
5. Rajiv Batish, CE (Programmes)

(The senior most amongst the Directors shall be the Chairman of the committee)

- a. The committee shall meet every Monday, Wednesday and Friday of the week at 11:00 AM (or as decided mutually as per situation).
- b. The meeting may be held by VC or physically as mutually decided by the members.
- c. The directions and decisions of the committee shall be complied with by all field functionaries.
- d. A weekly report shall be submitted by the committee for the information of the Government.
- e. Any exigency shall be immediately brought to the notice of all the higher authorities including the undersigned.
