Subject: Financial powers of various Committees/ authorities for deciding Procurement of Services required by various Govt. Departments/ Govt. Agencies through Tendering Process.

Whereas sufficient provisions have been provided for the finalization of Procurement of Stores/ Goods required by various Govt. Departments/ Govt. Agencies, the matter regarding competent authorities for deciding the procurement of various types of Services required by Govt. Departments/ Govt. Agencies was inviting the intention of the State Government for some time.

Having considered the relevant matter, the Government has decided that the competent authorities and the financial powers vested with them for deciding the procurement of various types of Services shall be as under:-

A. To finalize the Procurement of Services for which Specific Indents are received by Directorate of Supplies & Disposals, Haryana:-

a. Scope:- The scope of Procurement of Services which includes Goods/Stores as a component of the Service and are within the purview of DS&D as per Manual of Office Procedure for Supplies & Disposals of Stores and which are tendered & processed by Supplies & Disposals Department, Haryana.

b. Competent authority/ value for finalization of procurement of Services:-




