Whereas sufficient provisions have been provided for the finalization of Procurement of tores/ Goods required by various Govt. Departments/ Govt. Agencies, the matter regarding competent outhorities for deciding the procurement of various types of Services required by Govt. Departments/ Govt. Agencies was inviting the intention of the State Government for some time.

Having considered the relevant matter, the Government has decided that the competent authorities and the financial powers vested with them for deciding the procurement of various types of Services shall be as under:
