Subject: Special High Powered Committee constituted vide Govt. Order No. 2/7/2006-4I B-II dated 29.06.2011 issued by Department of Industries & Commerce- Expanding the Scope of Work.

The State Government vide its order No. 2/7/2006-4I B-II dated 29.06.2011 had constituted Special High Powered Committee to consider and decide/ approve procurement of Consultancy and Allied Services related to PPP Projects and the e-Governance Projects. Further, the State Government vide its order No.2/2/2016-4I BII dated 29.08.2016 revised the financial power of the said committee involving a financial outgo from below Rs.50 Lakhs & above to financial outgo of Rs. 1.50 Crores & above.

The matter regarding expanding the Scope of Work for the above referred committee was under consideration of the State Government from some time and having considered the same, the Government has decided to add the following content after Para-6 (v) in the said Govt. notification No. 2/7/2006-4I B-II dated 29.06.2011:-

"6 (vi) The above committee will also be competent authority for finalizing the cases of Procurement of Services for various Govt. Departments/ Govt. Agencies as per the financial competencies decided by the State Govt. from time to time. The Administrative Secretary of the concerned department will act as Member Secretary of the Committee in such cases."

This issues with the concurrence of Finance Department conveyed vide their U.O. No. 1/25/2013-4FD III/3738 of dated 06.07.2017.

The above instructions may be brought to the notice of all concerned for its implementation.




