Policy regarding Water Conservation Award to Village Panchayats.

Water and Sanitation Support Organization of Public Health Engineering Department, Haryana intend to reward progressive village panchayats for their achievements towards water conservation. The year 2011 was celebrated as "Water Conservation year" with major impetus and focus toward achieving drinking water security and sustainability of water sources. The reward may be given to village panchayat in a function held at district level on 26th Jan or 15th August.

The eligibility criteria for award (one time untied grant) and amount are as under:-

i) Eligibility Criteria

- The village panchayats who ensure provision of taps on all the private and public connections and,
- A minimum of 75% of the households have sanctioned private water connections in the village.

ii) The amount of the reward shall be as under :-

Population of village as per 2001 census	Amount of Reward
Upto 2000	Rs.20,000/-
More than 2000 upto 3000	Rs.30,000/-
More than 3000 upto 4000	Rs.40,000/-
More than 4000	Rs.50,000/-

Note: The village panchayat shall be considered as a unit for giving reward and shall include all the habitation.

The Gram Panchayat shall submit its request for reward to concerned Executive Engineer of Public Health Engineering Deptt. The eligibility of the Panchayat for the entitlement of the award shall be checked and verified by a committee consisting of officers of the rank of Sub Divisional Engineer in Public Health Engineering Department and an officer from Development and Panchayat Department, Haryana duly appointed by respective Deputy Commissioner of the District. The said committee shall submit its recommendations to the respective Executive Engineer of Public Health Engineering Department. The approval for the grant of award shall be accorded by respective Superintending Engineer, Public Health Engineering Department on the basis of recommendations of the Committee and recommendations of Executive Engineer.

The reward amount shall be paid by Executive Engineer of Public Health Engineering Deptt. The expenditure shall be chargeable to NRDWP (Support Fund). The policy shall continue till the continuation of National Rural Drinking Water progarmme.
