Please refer to your communication no 16764 dated 6th July, 2016; regarding the Enhancement of scale of the consolidated monthly emoluments for State & District Consultants, Accountants and BRCs (water sector) in Haryana state.

In this context, it is pertinent to mention here that the MoDWS has already prepared a detailed framework for implementation of the National Rural Drinking Water Programme (NRDWP) scheme. In this extensive framework, to provide the financial support to the activities like WSSO, DWSM, BRCs, IEC, HRD, MIS and computerization, R&D etc, the Support fund in NRDWP scheme has been stipulated. The present sharing pattern between the Centre and the State for this component is 60:40.

The scale of consolidated monthly emoluments as per the NRDWP framework is:

- 3. In view of the above, it is to inform you that as per the NRDWP framework, the NRDWP support fund may be utilised for the emoluments purpose within the scale of consolidated monthly emolument limit as mentioned in the table above. The fund sharing pattern between the Centre and State for this purpose shall be 60:40, as already mentioned in para 2.
- **4.** However, State Government is allowed to enhance this scale of monthly emoluments of the above functionaries. In that situation, the Ministry of Drinking Water and Sanitation, Government of India shall not bear any additional financial liability arises due to enhancement in the monthly emolument. The additional financial liability out of above to the NRDWP framework's consolidated monthly emoluments limit, shall be solely borne by the State itself.
