The proposal received in this office vide your office letter under reference is returned with the following remarks:-



1. The rate in the proposal is too high.
2. No theme have been mentioned for conducting the song and drama.
3. The name of the agency who wants to conduct these activities and selection criteria of the agency have not mentioned.
4. The proposal for conducting these types of activities with objectives and outcomes are not mentioned in it.

Hence, it is directed that while doing these types of activities keeping in view of the above, the following conditions may be ful-filled at your end:-

1. Agency / firm / natak mandli should be registered with Information and Broad Casting Department at State Government level / Center Government level.
2. The rate should not be exceeded from the rate list provided by the Information & Public Relations Department, Haryana or provided by the Ministry of Information & Broad Casting Department, Govt. of India.
3. The objectives and outcomes should be clearly mentioned in the proposal before conducting these types of activities.
4. Before releasing, the amount / payment, the progress report should be submitted with number of participants participated in the programme including participants signatures list, photographs and success ratio to the appointing authority i.e. concerned Nodal Executive Engineer.
5. The programme should be conducted only in those villages where actual requirement is needed and also the Officers / Officials/ Staff of WSSO should be present in each and every programme.



