Supplementary Resolution No. 4

Functioning of Block Resource CoordinatoRs. (BRCs).

It was brought to the notice of the Members of the Board that as per guidelines of Government of India under National Rural Drinking Water Programme, Water Support and Sanitation Organization (WSSO) was set up on the pattern of other States where the water supply and sanitation services are being looked after by one department. However, in Haryana State, these services are being looked after by two different departments, namely, Public Health Engineering Department for water supply and Development & Panchayats Department for sanitation. The main functions of WSSO are to carry out support activities like Information, Education & Communication, Human Resource Development, Water Quality Monitoring and Surveillance, Research & Development etc. As per provisions in the guidelines, Block Resource Centres were set up in each Block and 125 Block Resource CoordinatoRs., in addition to 21 District IEC & Equity Consultants in Water Sector (PHED), 21 District Sanitation & Hygiene Consultants in Sanitation Sector (D&P) and State Consultants two each in Water Sector/Sanitation Sector, were appointed after approval from Government.

The Block Resource CoordinatoRs. were appointed both for water supply and sanitation sectoRs. As per guidelines of NRDWP, the Block Resource Centres shall be located in the office of Block Panchayat and ordeRs. issued by Development & Panchayats Department vide their letter No. 1403-MEC-NBA-Consultant (HRD&IEC)/ 2013/3623 dated 5.9.2013, the sitting arrangement for Block Resource CoordinatoRs. was made in the office of respective BDPO office and they were directed to mark their attendance in a separate register to be maintained in the BDPO office, for effective functioning of Block Resource Centres. It has been observed that the Block Resource CoordinatoRs, are being engaged in the duties of Sanitation and some duties which are not related to NRDWP are also being assigned to them by Block Development & Panchayats Offices and water supply sector is being ignored. Due to this, the activities relating to Water Sector are suffering resulting non-achievement of desired goals and achievement of objectives of the scheme Subsequently, Development and Panchayats Department has appointed Assistant District CoordinatoRs. (in some districts), Block Resource Coordinator in each block and MotivatoRs as per requirement of the concerned district for Sanitation and related services and appointment is in process for other districts Thus, there is sufficient staff under Sanitation Sector

It is, therefore, proposed to consider and approve the following action :-

- (i) 125 Block Resource CoordinatoRs. appointed by WSSO at initial stage for both sectoRs. i.e. water supply & sanitation, may be assigned the activities relating to water sector only as independent Block Resource GoordinatoRs. and MotivatoRs. for Sanitation under Nirmal Bharat Abhiyan (NBA) have been appointed/ are in process of appointment exclusively for sanitation work.
- (ii) The sitting arrangement of Block Resource CoordinatoRs., as indicated at S.No.1 above, be made in the offices of Public Health Engineering Department.

Approved subject to condition for the districts where staff has been recruited by the Development & Panchayats Department under NBA. However, existing staff will work for both departments where recruitment has not been done.
